- Public Safety:

 - 3. Camera rebate program: use it! A neighbor has received \$200 and it has been useful.

o Park:

- 1. We now have signs that say "PARK CLOSED AT DARK" so call MPD if there are people hanging out and lingering.
- 2. 2017 monthly park clean up will start March 4, 10am-12pm. There are trash bags, gloves, coffee, so come on out and help!

- 3. Opening day for Common Good City farm is April 15th.

We asked DGS to clean that up and Anita will follow up with all these things.
- 10. Also rehabilitate the "hill" empty space. They are working on it. There's an opportunity to testify to the DC committee that manages DPR.
- 11. Last year it took a long time to get the lights replaced. Now we can go straight to DPR.
- 12. There was a group of people who signed up to water the trees. We may do something similar for the summer.

 - 1. 3/10 public hearing opportunity
 - 2. 3/21 limited scope hearing
 - 3. McMillan site is next to the reservoir. The developers develop a large medical building, townhomes grocery store, park & community center.
 - 4. There has been lots of support and lots of protest. DC, developers, and friends of McMillan (Zeba is part of this). Friend of McM. brought a law suit. Now we are back to having public hearing on this.
 - 5. Concern for Traffic: there was a traffic study done. But did not do a lot of north and south.
- John Clarke from the Mayor's office. Grew up not too far from this block.
 We have a new police chief! Mayor has recently allocated additional funding to school focusing extracurricular activities, and cont. to invest in education. John.clarke@dc.gov
- Councilmember Nadeau's office. Ty is community director of councilmember's office. Airbnb legislation: Still under council review. CM Nadeau hasn't taken a position. There has been "illegal hotels" (as long as it's your primary residence) so seeking to find a balanced approach. If anyone has thoughts please let them know. Also hosting a community convo March 20, agenda not set yet.
